**Business Travel Only** – these days will be charged to Lawlink and the employee issuing the policy will not pay for anything at the time of purchasing the policy.

**Leisure Travel Only** – payment for these leisure days will be required at time of booking and collected by credit card at the time of purchasing the policy

**Business & Leisure** – this is when the trip is a mix of business travel and leisure travel. The traveller will only be charged for the leisure days and then Allianz will issue an invoice to collect the business day portion from Lawlink.

When entering your requirements, be sure to select the Lawlink **firm you work for** (firms are listed alphabetically and the default is Anderson Lloyd). The personal information you have entered at Registration flows through to the form.
